- (2) Accounting adjustment on bank debt represents unamortised element of capitalised fees arising on refinancing in August 2008
- (3) Accounting adjustment on Eurobonds is combination of fair value adjustment on novation of bonds from BAA Airports Limited to BAA Funding Limited, unamortised element of fees capitalised on refinancing in August 2008 and foreign exchange revaluation reflecting movement in £/€ exchange rate between 18 August 2008 and 30 June 09
- (4) APP debt represents BAA's share of the net debt in its joint venture Airport Property Partnership ("APP") which was included within assets held for sale between 2007 and September 2008 but has been brought back on balance sheet following a decision to sell just part rather than all of APP's business
- (5) Due to the decision to sell Gatwick, the relevant debt has been reclassified as 'Held for sale' and excluded from the 'Accounting Value' column
- (6) Accounting adjustments and accounting value of 'Other' debt include bank overdrafts
