

2024 PARKING HIGHLIGHTS

Deep clean of Authorised Vehicle Area (AVA) seating shelter (see right) and new improved seating installed

Improved cleaning regime at AVA – 2 cleaners now onsite all day

Increased communication of AVA & 'Taxi Feeder Park (TFP) via trade communications and leafleting within local community via Heathrow Rangers (see right)

Undertaken a questionnaire of AVA users, to get a better understanding of their needs and to prioritise further enhancements, with over 500 responses

Funding for Public Space Protection Order (PSPO) enforcement in Hillingdon and Spelthorne

Over 1500 parking interventions in Spelthorne PSPObetween May-Dec 24

Increased signage within local communities (see right)

Reporting portal for residents to report nuisance parking launched in Q2 (April 2024) –163 reports within the first year

Conducted a review into pricing at AVA – £1 hourly fee to remain

Local authorities could then enforce against waiting private hire drivers more easily.
