3 PROJECT UPDATES

Local Planning Principles and Encroachment

Sub group - Colin Stanbury (CS), Nicole Porter (NP) and Xavier Oh (XO)

- Progress update by XO:
 - Meeting held with XO and CS
 - Potential to merge items 3.6 on planning principles and guidance, and 3.8 on a common position on encroachment.
 - Key documents Noise Policy Statement for England (NPSE), National Planning Policy Framework (NPPF), Planning Policy Guidance N (PPG-N 2019) and Professional Practice Guidance on Planning & Noise (ProPG), as well as Draft Aviation Strategy 2050 and Hounslow Plan as a case study.
 - Encroachment monitoring could use Office for National Statistics (ONS) LSOA (Lower Superior Output Area - groups of about 1500 homes) or CACI consumer classification postcode-based data.
 - Local authority engagement XO has been discussing with Expansion Community Relations group potentially including the Heathrow Strategic Planning Group (HSPG).
 - First draft document still in process.

Respite Working Group (Nicole Porter)

NP - Noise Expert Review Group (NERG) update was provided last week:

- NERG Expert review group advising Expansion team.
- Phase 3 progress on respite includes interim draft report.
- Recent work includes reviewing progress, including expansion and airspace design work, consultation feedback and stakeholder input.
- Phase 2 wasn't published because it was deemed the picture was incomplete. Some results unexpected, some mixing of relief and respite.
- Phase 3 includes review, social surveys, qualitative analysis.
- Proposed "Wrapper" report in development, possibly for publication before Development Consent Order (DCO) application.
- NERG to review in a similar manner to the Phase 1 Review Group.
