Operational Safety Instruction **Aerodrome Manual**

It is the responsibility of all employers to ensure that relevant OSIs are brought to the attention of their staff. However, individuals remain responsible for their own actions and those who are in any doubt should consult their Supervisor or Manager.

1. Introduction

- 1.1 The Aerodrome Manual ("The Manual") forms an important part of the certification process required by the Competent Authority with respect to the operation of the aerodrome. This document complies with all applicable requirements as detailed in ADR.OR.E.005 and is in accordance with the terms of the aerodrome certificate.
- 1.2 The principal purpose of The Manual is to describe how the aerodrome management will discharge its safety responsibilities. (Section A.1.1).
- 1.3 The Manual and its associated documents contain information relevant to the safe operation of Heathrow's airfield. It describes the aerodrome services and facilities, the airfield management structure and responsibilities, the aerodrome safety management system, and provides references to pertinent operational procedures and standards.
- 1.4 The Manual is published in a number of formats:
 - 1.4.1 World-Wide-Web: The Manual is published on Heathrow's website and is accessible general public aerodrome https://www.heathrow.com/company/team-heathrow/airside/useful-publications.
 - 1.4.2 Electronic format (Email): copies of The Manual are available to aerodrome users (Airlines, Handling Agents, Service Providers, Control Authorities) via email upon request. All users are notified by means of an Operational Safety Instruction when a new version of The Manual is issued.
- A new version is in circulation and will be effective from 12th May 2025. Version 9.0 1.5 replaces Version 8.0 that was published on 7th February 2025.
