## **SME Academy Privacy Notice**

## How long will Heathrow keep my information?

We will only hold your information for as long as we do the SME Academy activities. Your information will be retained in a secure environment and access to it will be restricted according to the 'need to know' principle.

Data will be retained for 3 years after the last engagement with SME's who have expressed an interest, at which point an email will be sent to those who have not engaged with an email to advise them that they will be removed unless they respond with a positive email to remain on the mailing list.

We will not transfer or disclose your personal information, other than as identified in this Privacy Notice, to our trusted third-party suppliers, to the police, tribunals, courts, regulators, or other authorities to assist them with their investigations or requests or for us to report security incidents or suspected or actual unlawful acts and/or as may be otherwise required by law.

## What rights do I have over my personal data?

- Rectification, erasure or restriction of your information where this is justified
- Object to the processing of your information where this is justified
- Data portability
